I. Situation Overview

On 07 May 2025 at around 4:00 AM, a fire incident occurred in Brgy. Layog, Maasin, Iloilo. The fire was declared out at around 5:00 AM.

A total of ₱8,077.00 worth of assistance was provided to the affected person; of which, ₱6,854.00 from DSWD and ₱1,223.00 from the Local Government Unit (LGU) (see Annex D).
