

## DSWD DROMIC Report on the Fire Incident in Brgy. Layog, Maasin, Iloilo 27 May 2025, 6AM

### I. Situation Overview

On 07 May 2025 at around 4:00 AM, a fire incident occurred in Brgy. Layog, Maasin, Iloilo. The fire was declared out at around 5:00 AM.
