

DSWD DROMIC Report on the Fire Incident in Brgy. Lopez Jaena, Murcia, Negros Occidental

21 May 2025, 6PM

I. Situation Overview

On 12 May 2025 at around 12PM, a fire broke out in Brgy. Lopez Jaena, Murcia, Negros Occidental. One residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Lopez Jaena, Murcia, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Lopez Jaena, Murcia, Negros Occidental (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,508.00** worth of assistance was provided to the affected family; of which, **₱7,508.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
