

## DSWD DROMIC Report on the Fire Incident in Brgy. Lopez Jaena, Murcia, Negros Occidental

21 May 2025, 6PM

### I. Situation Overview

On 12 May 2025 at around 12PM, a fire broke out in Brgy. Lopez Jaena, Murcia, Negros Occidental. One residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

**One (1) family or four (4) persons** were affected in **Brgy. Lopez Jaena, Murcia, Negros Occidental** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or four (4) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Lopez Jaena, Murcia, Negros Occidental** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱12,508.00** worth of assistance was provided to the affected family; of which, **₱7,508.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
