## I. Situation Overview

On 14 May 2025 at around 3:35 PM, a fire incident occurred in Brgy. Mohon, Arevalo, Iloilo City. The fire was declared out at around 4:30 PM.

#### **Outside Evacuation Center**

A total of **Two (2) families** or **12 persons** temporarily stayed with their relatives in **Brgy. Mohon, Arevalo, Iloilo City** (see Annex B).

# IV. Damaged Houses

A total of **2 houses** were **totally** damaged in **Brgy. Mohon, Arevalo, Iloilo City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of ₱24,660.80 worth of assistance was provided to the affected families; of which, ₱14,044.00 from DSWD and ₱10,616.80 from the Local Government Unit (LGU) (see Annex D).
