

DSWD DROMIC Report on the Fire Incident in Brgy. Monamon Sur, Bauko, Mountain Province

03 May 2025, 6PM

I. Situation Overview

On 16 March 2025 at around 7:17 AM, a fire incident occurred at Sitio Bebe, Brgy. Monamon Sur, Bauko, Mountain Province. The incident resulted in the complete destruction of a residential structure, displacing one (1) family.

One (1) family member sustained first-degree burns to the hands and face. She received immediate first aid from responders of the Bureau of Fire Protection (BFP) and was initially brought to Luis Hora Memorial Regional Hospital for treatment. She was later transferred to Baguio General Hospital and Medical Center for further medical care. The other affected family member temporarily stayed with relatives following the incident.

One (1) family or two (2) persons were affected in **Brgy. Monamon Sur, Bauko, Mountain Province** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Monamon Sur, Bauko, Mountain Province** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱33,383.91** worth of assistance was provided to the affected family; of which, **₱31,183.91** from **DSWD** and **₱2,200.00** from the **Local Government Unit (LGU)** (see Annex D).
