

# DSWD DROMIC Report on the Fire Incident in Brgy. Napaliong, Jones, Isabela

04 May 2025, 6PM

#### I. Situation Overview

On 02 April 2025 at around 7:10 PM, a fire incident occurred at Zone 1, Brgy. Napaliong, Jones, Isabela. This led to the total destruction of a residential structure, displacing one (1) family. The affected family has since sought temporary shelter with relatives within the same barangay.

### II. Status of Affected Areas and Population

One (1) family or six (6) persons were affected in Brgy. Napaliong, Jones, Isabela (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

One (1) family or six (6) persons are still staying with their relatives while recuperating from the incident (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Napaliong, Jones, Isabela (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱60,747.35 worth of assistance was provided to the affected family; of which, ₱33,847.35 from DSWD and ₱26,900.00 from the Local Government Unit (LGU) (see Annex D).
