

DSWD DROMIC Report on the Fire Incident in Brgy. Nueva Sevilla, Barotac Viejo, Iloilo

30 May 2025, 6AM

I. Situation Overview

On 17 May 2025 at around 12:37 PM, a fire broke out in Brgy. Nueva Sevilla, Barotac Viejo, Iloilo. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 1:30 PM. The fire completely destroyed a residential structure, displacing one family who has since sought temporary shelter with relatives.

One (1) family or or four (4) persons were affected in Brgy. Nueva Sevilla, Barotac Viejo, Iloilo (see Annex A).

Outside Evacuation Center

One (1) family or or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Nueva Sevilla, Barotac Viejo, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P6,976.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
