

DSWD DROMIC Report on the Fire Incident in Brgy. Pagbabangnan, San Julian, Eastern Samar

22 May 2025, 6PM

I. Situation Overview

On 07 March 2025 at around 5:30 PM, a fire broke out in Brgy. Pagbabangnan, San Julian, Eastern Samar. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 7:30 PM. Several residential structures were destroyed. One family sought temporary shelter with relatives, while the other affected families chose to remain in their homes. No injuries or casualties were reported.

II. Status of Affected Areas and Population

A total of **four (4) families** or **12 persons** were affected in **Brgy. Pagbabangnan, San Julian, Eastern Samar** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **one (1) is totally damaged** and **three (3) are partially damaged** in **Brgy. Pagbabangnan, San Julian, Eastern Samar** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱40,000.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
