I. Situation Overview

On 21 May 2025 at around 12:30 AM, a fire incident occurred in Brgy. Panayakan, Tangalan, Aklan. The fire was declared out at around 3:00 AM.

A total of **Two (2) families** or **Three (3) persons** were affected in **Brgy. Panayakan**, **Tangalan, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **Two (2) families** or **Three (3) persons** temporarily stayed with their relatives in **Brgy. Panayakan**, **Tangalan**, **Aklan** (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Panayakan, Tangalan, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱22,396.00 worth of assistance was provided to the affected families; of which, ₱12,396.00 from DSWD and ₱10,000.00 from the Local Government Unit (LGU) (see Annex D).
