### I. Situation Overview

On 05 April 2025 at around 8:25 PM, a fire incident occurred in Brgy. Poblacion, Kiangnan, Ifugao.

### II. Status of Affected Areas and Population

A total of **three (3) families** or **10 persons** were affected in **Brgy. Poblacion, Kiangnan, Ifugao** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Poblacion, Kiangnan, Ifugao** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱47,563.25** worth of assistance was provided to the affected families; of which, **₱32,563.25** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
