## I. Situation Overview

On 16 May 2025 at around 9:15 AM, a fire incident occurred in Brgy. Sambog, Jaro, Iloilo City. The fire was declared out at around 9:53 AM.

#### **Outside Evacuation Center**

A total of **one (1) family** or **four (4) persons** temporarily stayed with their relatives in **Brgy. Sambag, Jaro, Iloilo City** (see Annex B).

## IV. Damaged Houses

**One (1) house** was **totally** damaged in **Brgy. Sambag, Jaro, Iloilo City** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱20,906.65 worth of assistance was provided to the affected families; of which, ₱7,022.00 from DSWD and ₱13,884.65 from the Local Government Unit (LGU) (see Annex D).
