

DSWD DROMIC Report on the Fire Incident in Brgy. Tugas, Makato, Aklan

29 May 2025, 6AM

I. Situation Overview

On 16 May 2025 at around 8:30 PM, a fire broke out in Brgy. Tugas, Makato, Aklan. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10 PM. The fire completely destroyed a residential structure, displacing one family who has since sought temporary shelter with relatives.

One (1) family or three (3) persons were affected in Brgy. Tugas, Makato, Aklan (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Tugas, Makato, Aklan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,720.00** worth of assistance was provided to the affected family; of which, **₱3,720.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
