

DSWD DROMIC Report on the Fire Incident in Brgy. Tugas, Makato, Aklan 29 May 2025, 6AM

I. Situation Overview

On 16 May 2025 at around 8:30 PM, a fire broke out in Brgy. Tugas, Makato, Aklan. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10 PM. The fire completely destroyed a residential structure, displacing one family who has since sought temporary shelter with relatives.

II. Status of Affected Areas and Population

One (1) family or **three (3) persons** were affected in **Brgy. Tugas, Makato, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **three (3) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tugas, Makato, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱13,720.00** worth of assistance was provided to the affected family; of which, **₱3,720.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
