

DSWD DROMIC Report on the Fire Incident in Brgy. Niog, City of Bacoor, Cavite

23 May 2025, 6PM

I. Situation Overview

On 18 May 2025 at around 6:07 PM, a fire incident occurred at De Leon Compound, Purok 3, Brgy. Niog, City of Bacoor, Cavite. The fire was declared out at around 6:30 PM.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) CALABARZON, in close coordination with the Local Government Unit (LGU) of City of Bacoor, Cavite, provided financial assistance to address the needs of the affected individuals.

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

One (1) house was **totally damaged** in **Brgy. Niog, City of Bacoor, Cavite** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱10,000.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
