

DSWD DROMIC Report on the Strong Wind Incident in Brgy. Panaquiao, Isabela, Negros Occidental

20 May 2025, 6PM

I. Situation Overview

On 28 April 2025 at around 2:30 PM, an episode of isolated rain accompanied by strong winds was experienced in Brgy. Panaquiao, Isabela, Negros Occidental. This sudden weather disturbance had a significant impact on at least one (1) household in the area. It partially destroyed a residential structure, displacing a family who has since sought temporary shelter with nearby relatives.

II. Status of Affected Areas and Population

A total of **one (1) family** or **four (4) persons** were affected in **Brgy. Panaquiao, Isabela, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **one (1) family** or **four (4) persons** temporarily stayed with their relatives (see Annex B). The family had already returned home after repairing the damage to their house.

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Panaquiao, Isabela, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,496.00** worth of assistance was provided to the affected family; of which, **₱7,496.00** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
