

## **DSWD DROMIC Report on the Strong Wind Incident in Brgy. San Isidro, Jaro, Iloilo City**

30 May 2025, 6PM

### **I. Situation Overview**

On 02 May 2025, at approximately 8:06 AM, a residential structure in Barangay San Isidro, Jaro, Iloilo City was completely destroyed after being struck by a tree that was uprooted due to strong winds associated with the Intertropical Convergence Zone (ITCZ). As a result of the incident, two families were displaced and had temporarily sought shelter with relatives.

Relative to the incident, the DSWD through its Field Office in Region VI, together with the Local Government Unit (LGU) of Iloilo City, provided relief augmentation to support the immediate needs of the affected families and individuals.

### **II. Status of Affected Areas and Population**

A total of **two (2) families** or **10 persons** were affected in **Brgy. San Isidro, Jaro, Iloilo** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. San Isidro, Jaro, Iloilo** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱31,021.40** worth of assistance was provided to the affected families; of which, **₱24,994.00** from **DSWD** and **₱6,027.40** from the **Local Government Unit (LGU)** (see Annex D).
