

DSWD DROMIC Terminal Report on the Armed Conflict in Maguindano del Sur

18 May 2025, 6AM

I. Situation Overview

On 8 March 2025, at approximately 4:00 PM, several families from Barangay Malingao and parts of Barangay Bialong in Shariff Aguak, Maguindanao del Sur, were forced to evacuate their homes due to the imminent threat of an armed conflict between the two (2) opposing groups in the said municipality.

On 9 March 2025, the situation escalated at around 11:00 PM, when a firefight between the rival factions intensified, resulting in a significant increase in the number of displaced families. This further forced many residents to seek refuge in neighboring municipalities, including Shariff Saydona Mustapha.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XII, in coordination with the concerned Local Government Units (LGUs), provided assistance to the affected families to address their immediate needs.

II. Status of Affected Areas and Population

A total of **3,323 families** or **16,615 persons** were affected in **eight (8) barangays** in **Maguindanao del Sur** (see Annex A).

III. Status of Displaced Population

a. Inside Evacuation Center

A total of **853 families** or **4,265 persons** sought temporary shelter in **six (6) evacuation centers** in **Maguindanao del Sur** (see Annex B).

b. Outside Evacuation Center

A total of **15 families** or **75 persons** temporarily stayed with their relatives or friends (see Annex C).

c. Total Displaced Population

A total of **3,323 families** or **16,615 persons** were displaced in **Maguindanao del Sur** (see Annex D).

IV. Damaged Houses

A total of **15 houses** were **totally damaged** in **Maguindanao del Sur** (see Annex E).



V. Cost of Humanitarian Assistance Provided

A total of ₱2,375,945.00 worth of assistance was provided by **DSWD** to the affected families (see Annex F).
