

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Asin West, Malasiqui, Pangasinan

11 July 2025, 6PM

I. Situation Overview

On 28 April 2025 at around 8:40 PM, a fire incident occurred in Brgy. Asin West, Malasiqui, Pangasinan. Due to the incident, three (3) individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, together with the Local Government Unit (LGU) of Malasiqui, Pangasinan, immediately provided relief assistance to address the urgent needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Asin West, Malasiqui, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons are temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Asin West, Malasiqui, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,699.35** worth of assistance was provided to the affected family; of which, **₱16,249.35** from **DSWD** and **₱3,450.00** from the **LGU** (see Annex D).
