

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. BGH Compound, Baguio City

18 May 2025, 6AM

I. Situation Overview

On 02 March 2025 at around 8:30 PM, a fire incident occurred at #22 Purok 1, Brgy. BGH Compound, Baguio City. The fire was declared out at around 9:30 PM. Due to the incident, 12 individuals were affected and caused damage to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) Cordillera Administrative Region (CAR), together with the Local Government Unit (LGU) of Baguio City, promptly provided relief assistance to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or 12 persons were affected in **Brgy. BGH Compound, Baguio City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or 12 persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. BGH Compound, Baguio City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱21,687.40** worth of assistance was provided to the affected family; of which, **₱7,187.40** from **DSWD** and **₱14,500.00** from the **LGU** (see Annex D).
