

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Butac, Aguinaldo, Ifugao

21 June 2025, 6PM

## I. Situation Overview

On 04 May 2025 at around 11PM, a fire incident occurred in Brgy. Butac, Aguinaldo, Ifugao. The fire was declared out the next day at around 3:35 AM. No casualties or injured individuals were reported.

**One (1) family** or **three (3) persons** were affected in **Brgy. Butac, Aguinaldo, Ifugao** (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

**One (1) family** or **three (3) persons** temporarily stayed with their relatives (see Annex B).

#### IV. Damaged Houses

One (1) house was totally damaged in Buguias, Benguet (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱34,943.18** worth of assistance was provided to the affected family; of which, **₱24,943.18** from **DSWD**, and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
