

## **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Butac, Aguinaldo, Ifugao**

21 June 2025, 6PM

### **I. Situation Overview**

On 04 May 2025 at around 11PM, a fire incident occurred in Brgy. Butac, Aguinaldo, Ifugao. The fire was declared out the next day at around 3:35 AM. No casualties or injured individuals were reported.

**One (1) family or three (3) persons** were affected in **Brgy. Butac, Aguinaldo, Ifugao** (see Annex A).

**One (1) family or three (3) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Buguias, Benguet** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱34,943.18** worth of assistance was provided to the affected family; of which, **₱24,943.18** from **DSWD**, and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
