

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Mandalagan, Bacolod City

22 June 2025, 6AM

## I. Situation Overview

On 25 May 2025 at around 3:32 AM, a residential fire occurred in Barangay. Mandalagan, Bacolod City. The incident resulted in the total destruction of one house and the tragic death of a child. The cause of the fire remains under investigation by the Bureau of Fire Protection.

The fire displaced a family consisting of five individuals. The affected family, who are beneficiaries of the Pantawid Pamilyang Pilipino Program (4Ps), stayed with their relatives.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI and in coordination with the Local Government Unit (LGU) of Bacolod City, extended relief assistance and financial aid to address the immediate needs of the affected family.

Furthermore, the Bacolod City Government, through the City Social Welfare and Development Office (CSWDO), facilitated the provision of additional financial assistance in support to the bereaved family.

# II. Status of Affected Areas and Population

**One (1) family** or **five (5) persons** were affected in **Brgy. Mandalagan, Bacolod City** (see Annex A).

#### **Outside Evacuation Center**

**One (1) family** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

#### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Mandalagan, Bacolod City** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of **P48,018.00** worth of assistance was provided to the affected family; of which, **P28,728.00** from **DSWD** and **P19,290.00** from the **LGU** (see Annex D).
