

## DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Paknaan, Mandaue City

13 May 2025, 6AM

### I. Situation Overview

On 23 March 2025 at around 7 PM, a fire incident occurred in Brgy. Paknaan, Mandaue City. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10:32 PM. Several houses were destroyed, displacing families and individuals in the area.

### II. Status of Affected Areas and Population

A total of **271 families** or **1,007 persons** were affected in **Brgy. Paknaan, Mandaue City** (see Annex A).

### III. Status of Displaced Population

#### Inside Evacuation Center

A total of **271 families** or **1,007 persons** sought temporary shelter at a **gymnasium** in **Brgy. Paknaan, Mandaue City** (see Annex B).

### IV. Damaged Houses

A total of **180 houses** were damaged; of which, **173** are **totally damaged** and **seven (7)** are **partially damaged** in **Brgy. Paknaan, Mandaue City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱3,010,797.64** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
