

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Basi East, Solana, Cagayan

as of 11 June 2025, 6AM

I. Situation Overview

On 08 June 2025 at around 4PM, a fire broke out in Brgy. Basi East, Solana, Cagayan. The fire completely destroyed several residential structures, displacing numerous families in the area.

A total of **three (3) families** or **13 persons** are affected in **Brgy. Basi East, Solana, Cagayan** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are three (3) families or 13 persons currently taking temporary shelter at the Barangay Hall of Brgy. Basi East in Solana, Cagayan (see Annex B).

IV. Damaged Houses

A total of three (3) houses were totally damaged in Brgy. Basi East, Solana, Cagayan (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,140.30** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
