

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Isidro, Iriga City, Camarines Sur as of 14 June 2025, 6PM

I. Situation Overview

On 11 June 2025 at around 7:00 PM, a fire incident occurred at Zone 2, Caledonia Street, Brgy. Isidro, Iriga City, Camarines Sur. The fire was declared out at around 7:45 PM.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** are affected in **Brgy. Isidro, Iriga City, Camarines Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **One (1) family** or **five (5) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Isidro, Iriga City, Camarines Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,919.76** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
