I. Situation Overview

A total of 47 families or 235 persons are affected in Brgy. Poblacion, Glan, Sarangani (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are 47 families or 235 persons currently taking temporary shelter at the Municipal Gym in Brgy. Poblacion, Glan, Sarangani (see Annex B).

IV. Damaged Houses

A total of 43 houses were totally damaged in Brgy. Poblacion, Glan, Sarangani (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P390,842.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
