

DSWD DROMIC Report #1 on the Fire incident in Brgy. Kagingkingan, Anahawan, Southern Leyte

as of 20 June 2025, 6PM

I. Situation Overview

On 07 June 2025 at around 9:28 AM, a fire broke out in Brgy. Kagingkingan, Anahawan, Southern Leyte. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 10:37 AM. A residential structure was completely destroyed, displacing a family that lived there. No injuries or casualties were reported.

II. Status of Affected Areas and Population

One (1) family or three (3) persons are affected in Brgy. Kagingkingan, Anahawan, Southern Leyte (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **three (3) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in **Brgy. Kagingkingan, Anahawan, Southern Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱8,070.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
