

## DSWD DROMIC Report #2 on the Fire Incident in Brgy. Kinasang-an Pardo, Cebu City as of 16 July 2025, 6AM

### I. Situation Overview

On 01 June 2025, a fire incident occurred in Brgy. Kinasang-an Pardo, Cebu City. The Bureau of Fire Protection (BFP) promptly responded to the incident at around 12:30 PM and had the fire extinguished by 1:52 PM. Due to the incident, several residential structures were completely destroyed, displacing 319 individuals in the area.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VII, in close coordination with the Local Government Unit (LGU) of Cebu City, provided financial assistance (FA) to address the needs of the affected individuals.

### II. Status of Affected Areas and Population

A total of **89 families** or **319 persons** are affected in **Brgy. Kinasang-an Pardo, Cebu City** (see Annex A).

### III. Status of Displaced Population

#### Inside Evacuation Center

A total of **89 families** or **319 persons** sought temporary shelter at **Acacia Gymnasium** in **Brgy. Kinasang-an Pardo, Cebu City** (see Annex B).

### IV. Damaged Houses

A total of **38 houses** were damaged; of which, **37** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Kinasang-an Pardo, Cebu City** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱509,000.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
