### I. Situation Overview

On 05 June 2025 at around 12:15 AM, a fire incident in Brgy. Poblacion, Glan, Sarangani.

A total of **58 families** or **290 persons** are affected in **Brgy. Poblacion, Glan, Sarangani** (see Annex A).

### III. Status of Displaced Population

#### Inside Evacuation Center

There are **58 families** or **290 persons** currently taking temporary shelter at the **Municipal Gym** in **Brgy. Poblacion, Glan, Sarangani** (see Annex B).

### IV. Damaged Houses

A total of **50 houses** were **totally damaged** in **Brgy. Poblacion, Glan, Sarangani** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱970,842.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
