

DSWD DROMIC Report on the Fire Incident in Brgy. 17, Bacolod City

27 June 2025, 6PM

I. Situation Overview

On 19 June 2025 at around 4:16 PM, a fire incident occurred at Manolo St., Brgy. 17, Bacolod City, Negros Occidental. Due to the incident, eight (8) individuals were affected and caused significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Bacolod City, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **six (6) families** or **eight (8) persons** were affected in **Brgy. 17, Bacolod City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **six (6) families** or **eight (8) persons** temporarily stayed with their relatives in **Brgy. 17, Bacolod City** (see Annex B).

IV. Damaged Houses

One (1) house was **totally** damaged in **Brgy. 17, Bacolod City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱63,132.00** worth of assistance was provided to the affected families; of which, **₱37,392.00** from **DSWD** and **₱25,740.00** from the **LGU** (see Annex D).
