

## DSWD DROMIC Report on the Fire Incident in Brgy. 4, San Mateo, Isabela

23 June 2025, 6AM

### I. Situation Overview

On 13 June 2025 at around 2 AM, a fire broke out at Purok Doña Alicia, Quezon St., Brgy. 4, San Mateo, Isabela. A residential structure was completely destroyed, displacing the family living there. Since then, the family has sought temporary shelter with relatives.

In response, the DSWD, through its Field Office in Region II, has provided immediate relief assistance to support the needs of the affected family.

### II. Status of Affected Areas and Population

**One (1) family or three (3) persons** were affected in **Brgy. 4, San Mateo, Isabela** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

**One (1) family or three (3) persons** are still temporarily staying with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. 4, San Mateo, Isabela** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱26,930.70** worth of assistance was provided to the affected family; of which, **₱1,930.70** from **DSWD** and **₱25,000.00** from the **Local Government Unit (LGU)** (see Annex D).
