

## DSWD DROMIC Report on the Fire Incident in Brgy. Aurora, Santa Josefa, Agusan del Sur 25 June 2025, 6AM

### I. Situation Overview

On 29 April 2025 at around 8:30 PM, a fire incident occurred at Purok 6, Brgy. Aurora, Santa Josefa, Agusan del Sur. The fire was declared out at around 8:45 PM.
