I. Situation Overview

On 05 May 2025 at around 8:25 AM, a fire incident occurred at Purok 7, Brgy. Bayabas, City of Cabadbaran, Agusan del Norte. The fire was declared out at around 8:55 AM.

One (1) family or six (6) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Bayabas, City of Cabadbaran, Agusan del Norte (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P9,769.44** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
