

DSWD DROMIC Report on the Fire Incident in Brgy. Bulaquena, Estancia, Iloilo

14 June 2025. 6AM

I. Situation Overview

On 24 May 2025 at around 12:00 PM, a fire broke out in Brgy. Bulaquena, Estancia, lloilo. The Bureau of Fire Protection (BFP) promptly responded to the scene and successfully extinguished the fire by 12:30 PM. The fire destroyed a residential structure, resulting in the displacement of two (2) families.

A total of **two (2) families** or **10 persons** were affected in **Brgy. Bulaquena**, **Estancia**, **Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **10 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Bulaquena, Estancia, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P6,832.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
