

DSWD DROMIC Report on the Fire Incident in Brgy. Burgos, Cortes, Surigao del Sur 27 June 2025, 6AM

I. Situation Overview

On 09 June 2025 at around 6:30 AM, a fire incident occurred at Purok Bayabas, Brgy. Burgos, Cortes, Surigao del Sur. The fire was declared out at around 6:45 AM.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in **Brgy. Burgos, Cortes, Surigao del Sur** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Burgos, Cortes, Surigao del Sur** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,932.30** worth of assistance was provided to the affected family; of which, **₱9,932.30** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
