

DSWD DROMIC Report on the Fire Incident in Brgy. Cabilauan, New Lucena, Iloilo

10 June 2025, 6AM

I. Situation Overview

On 23 May 2025 at around 4:00 AM, a fire incident occurred in Brgy. Cabilauan, New Lucena, Iloilo. The fire was declared out at around 5:00 AM.

One (1) family or six (6) persons were affected in **Brgy. Cabilauan, New Lucena, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or six (6) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabilauan, New Lucena, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱12,522.00** worth of assistance was provided to the affected family; of which, **₱7,022.00** from **DSWD** and **₱5,500.00** from the **Local Government Unit (LGU)** (see Annex D).
