

DSWD DROMIC Report on the Fire Incident in Brgy. Caradio-an, City of Himamaylan, Negros Occidental

24 June 2025, 6PM

I. Situation Overview

On 09 June 2025 at around 3:00 PM, a fire incident occurred at Sitio Nasug-ong, Brgy. Caradio-an, City of Himamaylan, Negros Occidental. Due to the incident, 16 individuals were affected and caused damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, together with the Local Government Unit (LGU) of City of Himamaylan, Negros Occidental, immediately provided food and non-food items (FNIs) to address the needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **four (4) families** or **16 persons** were affected in **Brgy. Caradio-an, City of Himamaylan, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **four (4) families** or **16 persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **two (2)** are **totally damaged** and **two (2)** are **partially damaged** in **Brgy. Caradio-an, City of Himamaylan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱56,744.00** worth of assistance was provided to the affected families; of which, **₱26,744.00** from **DSWD** and **₱30,000.00** from the **LGU** (see Annex D).
