

DSWD DROMIC Report on the Fire Incident in Brgy. Culasi, Roxas City, Capiz

11 June 2025, 6AM

I. Situation Overview

On 07 June 2025 at around 7PM, a fire broke out in Brgy. Culasi, Roxas City, Capiz. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 8PM. The fire completely destroyed a residential structure, resulting in the displacement of a family, who sought temporary shelter with their relatives.

One (1) family or five (5) persons were affected in Brgy. Culasi, Roxas City, Capiz (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Culasi, Roxas City, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P7,000.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
