

DSWD DROMIC Report on the Fire Incident in Brgy. Dumolog, Roxas City, Capiz

14 June 2025, 6AM

I. Situation Overview

On 07 June 2025 at around 8:30 PM, a fire broke out in Brgy. Dumolog, Roxas City, Capiz. The Bureau of Fire Protection promptly responded to the scene and extinguished the fire by 9:00 PM. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Dumolog, Roxas City, Capiz (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **P7,000.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
