

DSWD DROMIC Report on the Fire Incident in Brgy. Dumolog, Roxas City, Capiz 14 June 2025, 6AM

I. Situation Overview

On 07 June 2025 at around 8:30 PM, a fire broke out in Brgy. Dumolog, Roxas City, Capiz. The Bureau of Fire Protection promptly responded to the scene and extinguished the fire by 9:00 PM. A residential structure was completely destroyed, displacing a family who has since sought temporary shelter with relatives.

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

One (1) house was **totally damaged** in **Brgy. Dumolog, Roxas City, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,000.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
