

DSWD DROMIC Report on the Fire Incident in Brgy. Gatbuca, Calumpit, Bulacan

06 June 2025, 6PM

I. Situation Overview

On 23 April 2025 at around 11:17 PM, a fire incident occurred at Purok 4, Brgy. Gatbuca, Calumpit, Bulacan. Due to the incident, five (5) individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) III, together with the Local Government Unit (LGU) of Calumpit, Bulacan, immediately provided food and non-food items (FNIs) and financial assistance (FA) to address the urgent needs of the affected individuals.

II. Status of Affected Areas and Population

A total of **two (2) families** or **five (5) persons** were affected in **Brgy. Gatbuca**, **Calumpit, Bulacan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Gatbuca, Calumpit, Bulacan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱18,000.00** worth of assistance was provided to the affected families; of which, **₱10,000.00** from **DSWD** and **₱8,000.00** from the **LGU** (see Annex F).
