

## DSWD DROMIC Report on the Fire Incident in Brgy. Guintas, Leganes, Iloilo

10 June 2025, 6PM

### I. Situation Overview

On 22 May 2025 at around 7:52 PM, a fire incident occurred in Brgy. Guintas, Leganes, Iloilo. The fire was declared out at around 8:21 PM.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of Leganes, Iloilo, provided food and non-food items to the affected family.

**One (1) family** or **six (6) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Guintas, Leganes, Iloilo** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱11,672.00** worth of assistance was provided to the affected family composed of **₱10,672.00** from **DSWD** and **₱1,000.00** from the **LGU** (see Annex D).
