

DSWD DROMIC Report on the Fire Incident in Brgy. Guinzadan Central, Bauko, Mountain Province

20 June 2025, 6AM

I. Situation Overview

On 12 May 2025, at around 11:48 PM, a fire incident occurred at Sitio Lucbuban, Brgy. Guinzadan Central, Bauko, Mountain Province. The fire was declared out at around 12:05 AM.

Due to the incident, a two-storey house solely owned by the affected two (2) individuals was damaged. The second floor was partially gutted by the fire, while the ground floor did not sustain any damages. The affected individuals opted to remain in their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office Cordillera Administrative Region (FO CAR), together with the Local Government Unit (LGU) of Bauko, Mountain Province, promptly provided relief assistance consisting of both food and non-food items (FNIs), as well as financial assistance (FA), to support the immediate needs of the affected individuals.

One (1) family or two (2) persons were affected in Brgy. Guinzadan Central, Bauko, Mountain Province (see Annex A).

III. Damaged Houses

One (1) house was partially damaged in Brgy. Guinzadan Central, Bauko, Mountain Province (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **P21,267.66** worth of assistance was provided to the affected family; of which, **P18,667.66** from **DSWD** and **P2,600.00** from the **LGU** (see Annex C).
