#### I. Situation Overview

On 11 June 2025 at around 2:00 PM, a fire incident occurred in Brgy. II (Poblacion), Hinigaran, Negros Occidental.

## II. Status of Affected Areas and Population

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. II (Poblacion)**, **Hinigaran**, **Negros Occidental** (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

A total of **two (2) families or nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

## IV. Damaged Houses

A total of two (2) houses were damaged; of which, one (1) was totally damaged and one (1) was partially damaged in Brgy. II (Poblacion), Hinigaran, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱28,362.00 worth of assistance was provided to the affected families; of which, ₱13,362.00 from DSWD and ₱15,000.00 from the Local Government Unit (LGU) (see Annex D).
