I. Situation Overview

On 11 June 2025 at around 2:00 PM, a fire incident occurred in Brgy. II (Poblacion), Hinigaran, Negros Occidental.

II. Status of Affected Areas and Population

A total of **two (2) families** or **nine (9) persons** were affected in **Brgy. II (Poblacion), Hinigaran, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families** or **nine (9) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** was **totally damaged** and **one (1)** was **partially damaged** in **Brgy. II (Poblacion), Hinigaran, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱28,362.00** worth of assistance was provided to the affected families; of which, **₱13,362.00** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
