IV. Cost of Humanitarian Assistance Provided

A total of **₱13,463.20** worth of assistance was provided to the affected family; of which, **₱10,223.20** from **DSWD** and **₱3,240.00** from the **Local Government Unit (LGU)** (see Annex D).
