

# DSWD DROMIC Report on the Fire Incident in Brgy. Jerusalem, Cadiz City, Negros Occidental

10 June 2025, 6PM

#### I. Situation Overview

On 21 May 2025 at around 7:00 AM, a fire incident occurred in Brgy. Jerusalem, Cadiz City, Negros Occidental. The fire completely engulfed a house, displacing a family that is still seeking temporary shelter with relatives.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected family.

## II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in Brgy. Jerusalem, Cadiz City, Negros Occidental (see Annex A).

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

# IV. Damaged Houses

One (1) house was totally damaged in Brgy. Jerusalem, Cadiz City, Negros Occidental (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱15,121.28 worth of assistance was provided to the affected family composed of ₱3,421.28 from DSWD and ₱11,700.00 from the Local Government Unit (LGU) (see Annex D).
