I. Situation Overview

On 21 May 2025 at around 2:00 PM, a fire incident occurred at Purok 5, Brgy. Liwayway, Diffun, Quirino.

A total of **two (2) families** or **six (6) persons** were affected in **Brgy. Liwayway, Diffun, Quirino** (see Annex A).

III. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Liwayway, Diffun, Quirino** (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of **₱19,098.70** worth of assistance was provided to the affected families; of which, **₱14,098.70** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex C).
