I. Situation Overview

On 08 June 2025 at around 9:00 PM, a fire incident occurred at Sitio Abagatanen, Brgy. Macaboboni, Agno, Pangasinan.

II. Status of Affected Areas and Population

A total of **six (6) families** or **25 persons** were affected in **Brgy. Macaboboni, Agno, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **five (5) families** or **17 persons** temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were **totally** damaged in **Brgy. Macaboboni, Agno, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱162,560.10** worth of assistance was provided to the affected families; of which, **₱125,396.10** from **DSWD** and **₱37,164.00** from the **Local Government Unit (LGU)** (see Annex D).
